3. FY 25/26 Budget Explanation

Executive Director Scheibly shared the JPA budget presentation to the LTF on the highlighting the budget structure, goals of aligning with the County of Marin's fiscal system Munis, and improvements for consistency, accuracy, and transparency.

The LTF discussions regarding disposal costs, solar panel repair and reuse job training program partnered with CCNB, repair fair, disposal generation, assessment fees, and budget reductions.

4. Recommendation from Subcommittee: Deconstruction (Information Only)

The subcommittee presented their recommendation for Deconstruction Educational Campaign. After providing background on the matter, the identified challenges (awareness/space markets) along with measures (FY-2026 outreach pilot program) were shared to address them.

Additionally, land use issues and high energy/GHG impacts were flagged as focal points for the suggested recommendation. In conjunction, reasoning for pursuing deconstruction/reuse campaigns and barriers to wider deconstruction adoptions were shared.

The subcommittee laid out proposed timelines, equity impact evaluations, compliance options, local jurisdiction variations, and fiscal impact estimates.

The LTF held a brief discussion regarding the proposal.

5. Subcommittee Updates (Information)

Infrastructure and End Markets reported goals of maintaining awareness of infrastructure issues within Marin County, propose recommendations to the JPA Board with ZWM staff collaboration, review the Waste Characterization Study to suggest improvements and be involved in the new subcommittee. Additionally, scheduling trips to visit sites.

Compliance and Regulation reported awareness of SB54 issues.

Outreach and Education reported their field trip organized by Resilient Neigborhoods for the Marin Sanitary Service tour. Highlighted the focus on the BYO initiative by generating a presentation for the Earth Day event.

Construction and Demolition reported ZWM website has a C&D best practices portion for reference.

6. Final Waste Characterization Study Report

ZWM staff Meilin Tsao shared in the June JPA Board meeting, the Board approved the final WCS report. The recommendation is staff host an ad-hoc meeting available to all LTF members to work on recommendations for implementation with the option to continue to meet for future discussions. Staff Fritz added thanks to the LTF and highlighted some of the included feedback the LTF that made it to the final WCS report. The meeting invite of the WCS will be sent out the second week of August.
